The Nanzih Interchange on National Freeway No. 1, located on the north side of the industrial park, is currently congested during peak hours. Upon completion of this project, northbound traffic from the

	<p>park will have direct access to the mainline of National Freeway No. 1, thereby reducing the traffic burden on both the Nanzih Interchange and the Dingjin System Interchange.</p> <p>2. The surface roads surrounding the Nanzih Industrial Park experience high volumes of vehicular and motorcycle traffic. After project completion, tank trucks will be able to directly access the mainline of National Freeway No. 1, avoiding interactions with mixed traffic on local roads. This will significantly reduce the risk of accidents and enhance road safety.</p>
